THE USE OF HAIR EXTENTIONS BY WOMEN IN ONDO WEST LOCAL GOVERNMENT AREA OF ONDO STATE

Abstract

The study examined the use of hair extensions by women in Ondo West Local Government Area of Ondo State. Four specific objectives and research questions were set to guide the study. A structured questionnaire with thirty items was used for data collection. Two hundred and ten respondents were involved in the research. Simple percentage and frequency count were used to analyze the data collected. The findings of the study reveal that, some hair extensions were made of different materials, such as: human hair, synthetics or mixed blends and can be added individually,in groups or by clip-on method. The findings also stated that hair extensions can be used to changea woman's appearance or look. Change short, thin hair to become long, lush and full. The study concludes that, the use of hair extensions by women is basically meant forself-beautification and fashion.

Introduction

Among the Yoruba people of Southwestern Nigeria, the head is given a highly reverend and the woman's hair is considered her crown and beauty. Therefore, over the years the Yoruba people have come up with various beautiful, exotic and dazzling hairstyles. In Yoruba land, hairstyles are not sometimes for fashion or beautification alone, they serve some purposes; it could be religious, identification,age passage,demonstration of spiritual powers or for celebrating specific traditional festivals. It could also signify the

marital status or mood of a woman. In the Yoruba married women adopted hairstyles in which the hair flows from the front down to the nape of the neck. Other styles were the ones which the hair comes from the forchead and from the back and then meet up at the center of the head. Although in the past, the different hair styles were done without the use of hair extensions. Then different Yoruba hair styles included iriunkiko (knotting with thread e.g. colling penny), irundidi (normal hair plaiting without thread,Koroba(bucket or pail) and Kolese.See some examples as shown in figures A, B, and C.

However, these hair styles have changed over time due to a number of reasons: technology, increase in travel and fashion changes among others.

What are hair extensions? These are hair extensions or artifcial hair integration. Hair extensions are methods of lengthening one's hair by incorporating artificial hair. Women have always wanted longer, fuller hair and have always worn wigs and use other forms of hair extensions to achieve that look. Some authors have traced the history of hair extension to the early civilization. According to Curious (2014), The origin of hair extensions dates back Cleopatra. The first documented proof of hair weaves were seen among the 3,400BC.In Egyptians Egypt, hair in extensions were both wom by men and women. They wore wigs, sewn on hair pieces and braids that were made of human hairs and dyed sheep wool attached to hair with resin and Bee wax. Both the European and American women were not left out in the business of using hair extensions. In the 1700s, white wig called Perukes were in use,king Louis was the first to use Perukes when his head started turning

bald,he wore wig to cover the baldness of his head and in no time, the noble men and women of his days followed this way of fashion

For centuries, European royalty wore elaborate wigs, Queen Elizabeth 1 of England famously wore a red wig,tightly and elaborately curled in a 'Roman' style and king Louis XIII of France pioneered wig wearing among men from the 1620s onwards. Women of the merchant class in northern Europe wore modified versions of courtly hairstyles, with coifs or caps, veils and linen wimples, that is, cloth which

covers the head and wrapped around the neck and chin. While the gray wig of the British barrister and the lacquered black wig of the Japanese illustrate occupational

associations with hair attachments (John &Bankhead 2014). See an example of a contemporary barrister with a wig in fig.1.

As earlier mentioned, globally women have always wanted longer, fuller hair for beautification and fashion. The woman hair is no doubt a symbol of beauty especially the long ones look very nice on women and could possibly have affective and emotional effects on people's imagination due to its beauty and luxury. Obasanho (2004)stated XieQiuping a Chinese was acclaimed to have the longest hair in the world. The length of her hair is 5.62m according to the record set in 2004. She began to grow her hair in 1973 when she turned 13 years old and she still keep the hair till date. However, according to other sources, XieQiuping no longer holds the record because affirms that, in India there is a woman living with curls, the length of which is nearly 8 meters (7m 92cm).

Chinese ChenqShiquin-a owner of a beauty salon on the other hand has not cut her hair in the last 16yea.rs,the length of her hair is 2.4m

Men are not left out in the hair fashion show, Tran HuyWai according to him has not cut his hair in the last 36 years. According to the source, the 67 years old man was determined not to cut his hairs in order to be recognized and to get into Guinness Book of Records. The same source further revealed that, American Asha Mandera is a world famous longest dreadlocks owner, 2.6cm in length. She said it took her 20 years to grow such long hair.

Observations from the pilot study conducted by the researcher in 2016 indicates that, there are misconceptions on the concepts of hair extension, therefore, the study is to examine the use of hair extension by women in Ondo West Local Government Area of Ondo State.Five specific objectives were set to guide the study. The study

- 1. examined women's perception on the concept of hair extensions:
- 2. highlighted reasons why women use hair extensions:
- 3. examined the perceived benefits of using hair extensions and
- 4. identified some challenges of using hair extensions
- 5. highlighted how natural hair can be maintained

Hair extension could mean any form of material, decoration, bond or chemical attached to the hair in order to improve its appcarance, length, colour or overall acceptability. Examples are hair weaves (human hair or synthetic) wig, Artmacasa, (wool), twine, rubber thread, relaxers, hair activator, conditioner, hair dyes and gels Banks (2000).

Methodology

The design used for this study was descriptive survey. Survey design is suitable for eliciting information from respondents without interfering with their responses (Durotolu,2006). The Study was carried out in Ondo West Local Government Area of Ondo State with a population of 283,672 (National Population Commission of Nigeria, 2006). There are 12 wards altogether in the Local Government and they are Newtown, Odosida, Yaba, Odojomu, Laje, Bagbe/Igunsin,Ilunla, Igbado, Okerowo,Surulere,Okelisa and Lekere.The areas covered were: Yaba, Odosida, Odojomu,Okerowo,Newtown,Okelisa and Surulere.The population of the study comprises of all hairstylists and women in the area of study. The population of women as at the last population census is one hundred and forty-four thousand, two hundred and seventy-two (144.272)

Population office Ondo West Local Governmennt(2006). Seven wards out of the twelve wards in Ondo were selected by balloting. From cach of the wards twenty (20) women were selected. A total of two hundred and ten (210) respondents constituted the sample size for the study. Purposive sampling technique was used for the selection women in the wards to ensure that women sampled were users of any form

of hair extender.A structured questionnaire of '4- point of strongly agreed, agreed, disagreed and strongly disagreed with values 4.3.2 and 1 assigned.Mean was used and interpreted based on the statistical real limits with 2.50 as the cut-off point accepted as agreed.

Results

Research Question 1:What is the perception of women on the concept of hair extensions? Table 1:Women's perception on the concept of hair extensions

Table 1 presents women's perception on the concept of hair attachment. The Table revealed that the mean responses of respondents on items 1,2,3,4,6, 7 and 9 ranged from 2.88 to 3.16 and were greater than the cut-off point(2.5)hence, respondents agreed to the statements. The table also revealed that the mean responses on items 5 (1.91),8 (1.78) and 10(1.75) were lesser than the

cut-off point (2.5),hence, respondents disagreed to the items statements.

Table 2 shows women's perception on the benefits of using hair extensions. The table revealed that the mean responses on items 1-5 ranged from 2.65 to 3.48 and were greater than the cut-off point (2.5),while items number. 5,8 and 10 mean lower than 2.5.

Table 2 presents women's reasons for using hair extensions. The table revealed that the mean responses on items 1,2,3,4,7 and 9 ranged from 2.93 to 3.20 and were greater than the cut-off point (2.5)hence, respondents agreed to the items statement.

Table 5 shows how natural hair can be maintained. The table shows that majority of the items were rated as their mean scores were greater than the criterion mean (2.5)

Discussion of Findings

Hair attachment as the name implies are attached to the hair to give the hair a better appearance. The study examined women's perception on the concepts of hair attachment and the study found out that women perceived that some hair attachments

are made of human hair, can be made from synthetics or mixed blends and can be added individually, in groups, or by clip-on method. Women also perceived that hair attachment is as old as hair styling and can be added by bonding, heat fusing and sewing. In support of this finding Bright (2014) noted that there are

nine traditional, methods of applying hair attachments

namely: bonding,tracking,fusion, suspension application, netting, free braiding, clip-in and clip-on hair extensions, lace application and micro braiding.

Furthermore, the study examined the reasons women use hair attachment and found out that the hair especially with attachment has the power to dictate how people treat others, hair attachments can be used to improve one's personal appearance, hair attachments are used for fashion and hair attachment promote the growth of natural hair. It also found out that hair attachment can be used to achieve youthful appearance and it is used by younger women to help them boost their status and make

them look more beautiful and attractive. With hair attachments (especially wigs) it is possible to change hairstyle and look as often as possible. The fashion industry and the business of "looking good"has become an agent of globalization. Women adopt hairstyles from all over the world using the mass media. Added to this most people now value (more) their appearance when compared to what it used to be in order to achieve this women wear hair attachments. Apart from this some set of people (especially the religious fanatic) can be identified by the kind of hairstyle they are wear. Some are referred to as the "old school" while some the "jasi". In line with the finding of the study Mercer (1994). Rooks (1996) Byrd and Tharps (2001). Jacobs Huey(2006)and Patton (2006) noted that in 15th century Africa, hairstyles were used to indicate a person's marital status, age, religion, ethnic identity, wealth and rank within the community. Hairstyles have historically represented social class and political stance (Rooks, 1996: Chapman, 2007). Journal of

The study also examined thebenefits of using hair attachments,it was observed that attachments, women's hair can be changed to any colour, they can wear different looks for different occasions with the aid of hair attachments and can change short, thin hair to long, lush and full. Hair attachments come and in different lengths. Women with different size and length of hair can improve the length and size of their hair with hair attachments. There is "full expression" for women with scanty hair, the attachment is fused into the hair in such a way as to make it blend with the natural hair and improved its appearance. Bald ladies can also wear wig to hide or disguise their hair deformity. Since some of these hair attachments are synthetic and produced industrially, it is therefore possible to have different length and sizes. Hair attachment

also come in different colours and can be dyc, this makes it possible for women to wear hair of different hair colour. It was also discovered that with hair attachments women can wear any style. Some hairstyles requires the hair to be scrapped or cut and most women would not want their hair cut, in this case, hair attachment is first added to the hair and rather than scrapping the natural hair, the attachment is scrapped or cut.

addition, the challenges of hair attachments based on the findings of the study were: it can cost a lot of money, it can cause hair damages, it can cause scalp irritation, it can cause inflammation and lead to temporary and permanent bald patches on the scalp. In finding this support of Wise. Palmer, Reich, Cozier and Rosenberg (2012) found out that harmful chemicals cause minor to severe hair loss including balding, burns... and color change, DeGruy (2006) noted that chemicals used in hair relaxers caused injury in the mouth and esophagus when ingested and s/reathmalesducation-leathing & Respector,

Lastly, this research work showed that hair dye is not good for the hair with mean value of 2.43. Items 2-8 under Table 5 all accepted their opinions respectively. This means that hairstyling is good for the upkeep of natural hair. It is preferable to use organic cream like "Damatol", "Soulmate", Sporting Waves" etc on natural hair to prevent hair dandruff and other hair rashes. Natural hair is easier to maintain as it takes lesser time and it is less costly. Daily shampooing is not necessary for natural hair unless the hair is exceptionally oily or it is exposed to large amount of dust. Thick natural hair is not inherently good or bad but it affects both the appearance and maintenance of the hair. Thick natural hair can clump and hang limp which does not look good. All these opinions show that natural hair can be maintained without any damage.

Conclusion

The study concludes that, the use of hair extenders by women is basically meant for self-beautification and fashion.

Recommendations

Based on the findings made and the conclusion drawn, the following recommendations were therefore made:

- i. The findings of this study should be made available to women in the local government in order to broaden their horizon and informed them on the concept of hair attachment
- ii. The use of hair extenders must not be too frequent to reduce its consequences on the hair.women should endeavour to go natural often
- iii. Women in the society should be reoriented so as not to place too much premium on the use of hair attachments and reduce the prejudice on people without hair attachments.
